
Visit to Designated Consumer

ESCerts Trading Process

As per BEE Office Memorandum no. 45/01/ESCerts Trading/22-23 dated February 06, 2023, and in continuation to Circular no. PXIL/Operations/2021-2022/389, Trading of ESCerts started from February 14, 2023 onwards.

The following are the major points in the ESCerts Trading Process.

- There will be no separate window for Banked ESCerts and New ESCerts. Both will be treated as cumulative.
- Floor price will be applicable for both Banked ESCerts and New ESCerts.
- DCs who are Eligible Entity will only be allowed to trade.
- Now there are 3 Power Exchanges namely:
 - i. Indian Energy Exchange Limited (IEX)
 - ii. Power Exchange of India Limited (PXIL)
 - iii. Hindustan Exchange Limited (HPX)


- DCs can register with either single power exchange or multiple power exchanges.
- Price and Volume will be discovered separately on all the power exchanges
 - i. Banked ESCerts of the Sellers
- Validity of ESCerts is now being made perpetual. This means banked ESCerts of the sellers shall have validity till the time it is not being sold.
 - ii. Banked ESCerts of the Buyers
- Banked ESCerts of the buyers who have bought excess ESCerts than what they are entitle to purchase, can use their banked ESCerts only for their compliance in their next notified cycle
- Present value of one ESCert = Rs 1840 (10% of Rs 18401, value of 1 Toe)

As per BEE Office Memorandum no. 45/01/ESCerts Trading/22-23 dated March 10, 2023, BEE has announced the last of ESCerts Trading for PAT Cycle -II DCs. The Trading window will remain open till last Tuesday of June, 2023 and thereafter that trading window will be closed. Therefore all the designated consumers (DCs) are requested to buy the ESCerts before closing of the trading window and comply with energy conservation norms and avoid penalty. Trading as per the approved procedure shall happen on every Tuesday and in case Tuesday is a gazette holiday, it will happen on the next working day
